



1.	Clause 3.3.1.8 of RFP	<p>The O&amp;M experience under clause 3.3.1.8 of RFP asks for O&amp;M experience in a Single Four Lane Road Project of 15 km. We understand that for constructing 30 km four lane road, the requirement is 15 km four lane road, i.e., half the experience.</p> <p>In the same way for constructing 30 km four lane road, the requirement can be 30 km two lane road which is also half the experience.</p>	No. Refer the contents in Clause 3.3.1.8 of RFP i.e., 15 km for Four Lane or 60 km for Two Lane.
2.	Clause 3.3.1.8 & Clause 2.3.2 (O&M Experience) of RFP	Generally, the O&M experience in EPC projects will overlap with Defect Liability Period, i.e. O&M and Defect Liability Period will start simultaneously and end simultaneously. In that case	In addition to the contents in the Clause 3.3.1.8 & Clause 2.3.2 (O&M Experience) of RFP, the O & M experience even during Defect Liability Period will also be considered provided that

Clause 3.3.1.1 Category 4	We have a construction experience of "Construction of multi-storied office complex building including Civil, Water Supply & Sewerage, External Cladding, HVAC, IBMS, Electrical & Fire Fighting System, Landscaping and Facade Access System". We understand that this experience is eligible in category-4 which stipulates construction in core sector. Do you consider this project as category -4.	No. The experience in construction of the multistoried office complex alone cannot be taken. However, the development activities such as road facilities, drain and other amenities related to this project can be considered.
4.	Clause 15.1 of DCA	In annuity projects risk of finances is high. Please considered COD for partially completed work so as to reduce the risk of interest and repayments of finance.	The bidders request cannot be considered. The contents of RFP clause 15.1 of DCA shall prevail.
