Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the World Bank's [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans by World Bank Borrowers, January 2011 Revised July 2014](#), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

5. For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities, authorized by Government of India for issuing DSC. Bidders can see the list of licensed CA's from the link (www.cca.gov.in).
6. Bids must be supported by a Bid-Securing Declaration as prescribed format (Section IV Bidding Forms 5. Forms of Bid-Securing Declaration). Bids must be submitted online on www.tntenders.gov.in, on or before the date and time for receipt of bids, and will be opened online on the specified time and date for opening of bids, as given above. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
7. The bidders are required to scan and upload (a) Bid-Securing Declaration, (b) Power of attorney to sign the bid and (c) affidavit regarding correctness of information furnished with bid document while submitting bids in the e-procurement portal (www.tntenders.gov.in). Only successful bidder is requested to submit the above-mentioned original documents before signing of agreement.
8. Other details can be seen in the bidding document. The Purchaser shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Purchaser shall not be liable for any information not received by the bidder.
