The Superintending Engineer (H), TNRSP II, Chennai for and on behalf of Governor of State of Tamil Nadu invites bids for the construction of works detailed below:

**Project Scope & Duration:**

The Scope of work will broadly include the Engineering, Procurement, Construction (“EPC”) for the upgrading of the existing carriageway to four lane for 30.600 km on EPC mode with horizontal and vertical alignment improvements, construction of new pavement, construction and/or rehabilitation of major and minor bridges, culverts, road intersections, drains, road safety enhancements etc.

Construction period is 18 months and the contractor shall also maintain the developed facilities for a period of 5 years from the date of issue of Provisional Certificate of Completion.

2. Bidding documents are available online and should be submitted online in <http://www.tntenders.gov.in/>. The bidder would be required to register in the web-site which is free of cost. To

participate in the e-tendering process, it is mandatory for the bidders to have class-III Digital Signature Certificate (in the name of person who will sign the proposal) from any of the licensed Certifying Agencies (Bidders can see the list of licensed CAs from the link [www.cca.gov.in](http://www.cca.gov.in) ). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in this Project, may obtain the same from the website: [www.tntenders.gov.in](http://www.tntenders.gov.in). The selected bidder is required to pay a non-refundable fee of Rs. 10,000/- (inclusive of Tax) before signing the Agreement.

3. Bidding is open to all eligible Bidders. Bidders are advised to note the minimum qualification criteria specified in Section III of Bidding Document to qualify for the award of the contract. Bidders are advised to download the bidding document prior to the pre-bid meeting in order to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
4. **Bids must be submitted on e-procurement system on or before 22/02/2021 at 11.00 hours (Local time as per server)** and will be opened online on **22/02/2021 at 11.30 hours**. Any bid or modification to bid (including discounts on bid submitted on e-procurement system) received outside e-procurement system will not be considered.
5. **Bidders are invited to attend a pre-bid meeting on 29/01/2021 at 15.00 hours** (refer RFP for additional information).
6. All bids must be accompanied by a Bid Securing Declaration as per ITB Cl.19.1 of the RFP of the bid document.
